Official VTS School Rules & Regulations

Please initial all items:

____1 - All new members, during the **90 days probationary period**, are to train only from 6:00 PM – 7:30 PM M-F, and optionally can attend regular hours on Saturday from 10:30 AM - 12:30 PM. (Check vingtsunsito.com/schedule too.)

____2 - **Membership** fees are \$150/mo. \$400 pre-pay for 3 months. (Check vingtsunsito.com/membership too.)

____3 - **Pay dues on time** - ideally seven days or more before the 1st of each of month. A \$10.00 late fee will be add for any tuition past due – not paid after the 7th day of the month. Example: Pay November dues before November 1st.

____4 - Members who are "inactive" must pay a \$50.00 monthly **inactive fee to hold membership**. Inactive fees will not exceed 3 months (or \$150.00) for any calendar year.

____5 - Members are expected to **practice, on average, twice a week, or more**. If you miss twice a week, you can make it up in the following week(s) in order to average twice per week, or 8 times per month. We assume two weeks vacation so it is very simple math: 50 weeks training per year, multiplied by 2 day per week, is a minimum of 100 attendance days per year.

____6 – There will some changes in **scheduling** – please be aware. Notification is by vingtsunsito.com/schedule, Facebook groups, signage in the school, and word of mouth. Schedule changes are due to school special events, dinners, trips, holidays, workshops, and special training events.

____7 - All members are required to bring a **clean indoor pair of shoes** and leave their outdoor pair of shoes in the hallway, or in plastic bags in their cubby.

____8 - All belongings will be **neatly** stowed away in one of the available cubbies or on our community shelves.

____9 - Please **wash** your own cups and throw out your trash before leaving.

____10 - **Wash hands and arms thoroughly** before-and-after practice from "fingertips-to-elbows" to prevent spreading germs. Also keep your fingernails cut and filed down.

____11 - All members have a responsibility to **keep our school clean and tidy**. Please do YOUR PART.

____12 - DISCLOSURE: For everybody's security and protection our school is under a 24x7 multiple-angle video and audio **surveillance**.
